JitendraHasda) vide letter dated 25.08.2021 had tender his resignation from Trustee of "**INJOT Trust**" due to his nomination as Member of Council Legislative Assembly (MCLA) OF Bodoland Territorial Council (BTC).The **THIRD PART/RETIRING TRUSTEE** had requested the **FOUNDER/PRINCIPAL TRUSTEE** and **CONTINUING TRUSTEE** to absolve him of any liabilities and responsibilities, which may further follow as per terms of the Registered Trust being Deed No. **11474/2020** dated 08.09.2020.

AND WHEREAS, the above-named **FOUNDER/PRINCIPAL TRUSTEE** and **CONTINUING TRUSTEE** having understood the genuine difficulties being faced by **RETIRING TRUSTEE** acceded to the request and decided to execute this deed reconstituting the "**INJOT Trust**", and absolve him of any liabilities and responsibilities, which may further follow as per terms of the Registered Trust being Deed No. **11474/2020** dated 08.09.2020.



Madam,


With reference to the subject cited above I would like to inform you that from today onwards I do hereby tender my resignation as Trustee from Injot Trust due to reasons mentioned below.

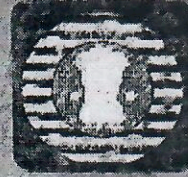

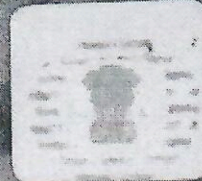

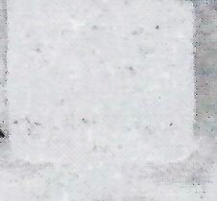
